Abstract

This study aimed to recognize the effect the Israeli aggression trauma reactions on the Palestinian a primary school during al agssa entifadah . (240) Palestinian children between (7 – 12) years of old was examined by using two Psychological tests which is mainly used in this topics . The study reach the following findings there are no Statistically significant differences between reactions that result of aggression trauma among males and females. There are no statistically correlated relation between reactions of aggression trauma among Gaza places . There are correlated relation between reactions of aggression trauma between children and their parents.
