### Abstract

The aim to identify academic prevalence ratios and is relationship to some psychological variables in children and adults in the southern Gaza strip from Aug - to Oct. 2009. The researchers has adopted the descriptive analytical. Approach was the study group of families that inhabit the border areas in southern Gaza strip (Rafah, Khanyones). The number of study samples are about (1146) lord of the family and their children, where selected randomly from Aug - to Oct. 2009 and may used Indicators of psychological variables prepared by the researchers. To validate the hypothesis of the study the researchers use all the following statistical methods:- percentage, repeating, S.M.A, S.D, M.C.C, ANOVA. The most important result that have been reached are:- Proportion of heads of house hold exposure to beinful accident are about 44.2%.
